### From the Assessor

The Oshtemo Board of Review, appointed by the Township Board, is comprised of Township residents who are responsible for hearing property tax valuation appeals from Oshtemo Township property owners. The Board of Review can hear appeals regarding the following: State Equalized Value (SEV), assessment roll classification changes, disabled veteran exemption requests and poverty exemption requests. After receiving your 2018 Assessment Change Notice and prior to March 9th, if you believe your property valuation is inaccurate or have general questions, please call the Assessor's Office (269) 216-5225 to discuss you concerns. If the Assessor is not able to address your concerns, you may schedule an appointment to appear before the 2018 March Board of Review to appeal the property valuation.

# **Ordinance Enforcement Update**

Oshtemo Township receives many resident concerns about traffic speeds, so the Township took action to respond to these safety concerns by investing in a second **radar speed trailer**. The technologically sophisticated speed trailer is dedicated for use on Oshtemo Township roads and neighborhoods. It is compact with a large speed display and a battery power system with solar panel charging, allowing the unit to be in nearly continuous use from location to location without downtime for recharging. The speed display for approaching traffic is a reminder of the speed limit and a caution for speeding drivers to slow down. On-board traffic data collection continuously captures vehicle speeds, direction, length and count for both approaching and departing vehicles. Partnering with the Kalamazoo County Sheriff's Office, reports are shared to help direct traffic patrol officers to areas of concern. The Township remains committed to the safety of residents and visitors, and this provides an important tool toward that goal.

The picnic shelter at **Flesher Field**, 3664 South Ninth Street, is conveniently located close to our newest playground and features an attractive wood pergola. It is handicap accessible, has two charcoal grills, and holds nine picnic tables.

Flesher Field's newest feature is a gazebo and garden area with native wildflowers, grasses, flowering shrubs and trees. It can be rented for outdoor weddings, concerts, and other events. Rentals include the 20' wide gazebo, lawn area with space for approximately 300 guests, and crushed stone paths. Tent space and electricity are available if desired.

The picnic shelter at **Township Park**, located behind the Township Hall at 7275 West Main Street, is strategically placed between the playground, tennis courts, and wiffleball field. It is handicap accessible, has a charcoal grill, and holds 12 picnic tables.

**Picnic shelter / gazebo rental fees for Oshtemo Township residents** are \$35 for a half day or \$70 for a full day from Monday through Thursday and increase to \$50 for a half day or \$100 for a full day from Friday through Sunday. Fees are higher for those that reside outside of Oshtemo Township.

**Grange Hall**, 3234 North 3rd Street, is a charming historic building with ties to Oshtemo's agricultural heritage. It is a wonderful venue for family reunions, dances, or concerts. The upper level has an open floor plan with hardwood floors, a raised stage, and restroom. The lower level features a kitchen, tables, chairs, and restrooms. Completely renovated in 2017, the building is now fully accessible. A small playground and basketball court are also located on site. **Rental fee** is \$100 on weekdays (Monday through Thursday) or \$150 on weekends (Friday through Sunday). Security deposit and proof of insurance liability are required. If alcohol will be served, a Host Liquor Liability Insurance Policy and additional security deposit are required. Rental is available only to Oshtemo Township residents.

Originally a fire station, the **Oshtemo Community Center**, 6407 Parkview, features two rooms that can be rented separately or together. Each room includes a small refrigerator, sink, microwave, tables, and chairs. A shared foyer and restrooms are located between the two rooms. **Rental fee** is \$50 for a half day or \$75 for a full day from Monday through Thursday and \$75 for a half day and \$100 for a full day from Friday through Sunday. Security deposit and proof of insurance liability are required. If alcohol will be served, a Host Liquor Liability Insurance Policy and additional security deposit are required. Rental is available only to Oshtemo Township residents.

# Oshtemo Fire and Rescue—Heating Fire Safety Tips

Our winter of 2017/18 has arrived with a vengeance. Its recent bone chilling temperatures are predicted to be with us for the foreseeable future. With that in mind, we wanted to remind everyone of a few home heating fire safety tips shared by the Federal Emergency Management Agency (FEMA).

### Furnaces

Your furnace typically sits idle all summer long and although not in use, it can deteriorate during that slumber. Rust and even the arrival of an unwanted pest can negatively alter is functionality and safety. Therefore, an annual inspection is recommended.

### Alternative heating sources.

As temperatures dip to new lows, installed heating systems sometimes struggle to keep up with demand. When alternative sources such as space heaters, fireplaces and kerosene heaters are employed, additional cautions must be taken to keep your family safe.

### Wood Stoves and Fireplaces

Keep the glass or metal screen closed on a fireplace to prevent hot embers from landing inside your home. Only burn dried, seasoned wood. Put the fire out before going to bed or leaving your home.

Any chimney servicing a wood burning device needs an annual inspection and cleaning. Countless house fires are caused by fires inside a chimney that penetrate into the structural members of a home. Even if you are home, these fires can get a stronghold long before occupants are aware of their existence.

### **Kerosene Heaters**

We always recommend that a unit be approved by an independent testing laboratory such as United Laboratories (UL). That will insure that the unit meets current industry safety standards. Never refill a Kerosene heater inside the house. Even when outside, always wait a few minutes until the unit has cooled before refueling. Hot surfaces and flammable liquids are not a good mixture.



Also, cold fuel can expand and overflow the container once taken into a warm house. Therefore, leave some space in the tank. At the least, spilled Kerosene onto your floor or carpet is nearly

impossible to remove. Worst case is that this flammable liquid will act as an accelerant should a flame come into contact.

Finally, as is the case for any appliance that produces heat, keeping all combustible materials at least 3' away is critical.

In support of his role as Department Chaplain, he has completed the Community Service Chaplaincy program, is certified in Critical Incident Stress Management, and is scheduled for certification training in First Responder Counseling in January 2018. Steve and his wife Beth, remain committed to the needs of their church and our community while enjoying the growth of their 7 grandchildren.

# Oshtemo Police Protection Update

In 2015, the future of policing in Oshtemo Township was unclear. Negotiations between the Township and Kalamazoo County were stalled, and the possibility of the Kalamazoo County Sheriff's Department issuing pink slips to officers was likely. Instead, the Township and the County came together with an agreement to continue negotiations to maintain police service. By spring of 2016, Oshtemo Township and Sheriff Rick Fuller amended the contract to include an officer who would focus on community policing, to clarify the role of the lieutenant assigned to the Township, and to include more detailed reports regarding crime statistics, trends and calls for service.

Sheriff Rick Fuller, along with Oshtemo Township Officials, had a vision to provide an officer focused on specific community needs and spending time getting to know the community. Over a year later, Oshtemo using data extracted from the Kalamazoo County Sheriff's Office CAD system, the Township 'calls for service' are increasing from just over 16,000 in 2015, to over 21,000 calls in 2017. Lt. Faulk explained that some of this increase is a direct result of the increased directed patrols, up from 519 in 2015 to 2,145 in 2017. These patrols, combined with 920 public relations interactions, are part of the proactive community policing strategies that Sheriff Fuller and Oshtemo Township envisioned. Violent crime and property crimes, which had been steadily increasing in the Township since 2010, showed signs of leveling out in 2017, with some specific categories decreasing. In addition, recent December retail frauds from Oshtemo businesses were down 29% for the same time period in in 2016. This very dramatic decrease in retail fraud is a attributed to two key policing strategies: additional directed patrols strategized by the Oshtemo Lieutenant, and a zero tolerance policy adopted by Sheriff Fuller.

The community policing strategies in the partnership between Kalamazoo County, the Sheriff's Office, and Oshtemo Township are a success. As this model continues, Oshtemo officials expect to see continued improvement in crime levels in 2018.

#### Tax Season Warnings



The Sheriff's Office continues to warn residents about scam phone calls from thieves' intent on stealing their money or their identity. Criminals may pose as the IRS or other agencies to trick victims out of their money or personal information.

#### Tips on knowing a fraudulent call intent on gaining personal information:

- Scammers make unsolicited calls. Thieves call taxpayers claiming to be IRS officials. They demand that the victim pay a bogus tax bill. They con the victim into sending cash, usually through a prepaid debit card or wire transfer. They may also leave "urgent" callback requests through phone "robo-calls," or via phishing email.
- **Callers try to scare their victims.** Many phone scams use threats to intimidate and bully a victim into paying. They may even threaten to arrest, deport or revoke the license of their victim if they don't get the money.
- Scams use caller ID spoofing. Scammers often alter caller ID to make it look like the IRS or another agency is calling. The callers use IRS titles and fake badge numbers to appear legitimate. They may use the victim's name, address and other personal information to make the call sound official.
- **Cons try new tricks all the time.** Some schemes provide an actual IRS address where they tell the victim to mail a receipt for the payment they make. Others use emails that contain a fake IRS document with a phone number or an email address for a reply. These scams often use official IRS letterhead in emails or regular mail that they send to their victims. They try these ploys to make the ruse look official.

#### The IRS will not:

- Call you to demand immediate payment. The IRS will not call you if you owe taxes without first sending you a bill in the mail.
- Demand that you pay taxes and not allow you to question or appeal the amount you owe.
- Require that you pay your taxes a certain way. For instance, require that you pay with a prepaid debit card.
- Ask for your credit or debit card numbers over the phone.
- Threaten to bring in police or other agencies to arrest you for not paying.

#### Never give personal information to anyone over the phone or the internet.

- Do not give out any information. Hang up immediately.
- If you do receive a letter in the mail, take the letter to a tax professional for help.

• To Report an IRS imposter tax collection scam to the Treasury Inspector General for Tax Administration (TIGTA) call 1-800-366-4484. If you have questions regarding any type of solicited scams or you feel you may be a victim of a fraudulent scam call the Sheriff's Office and ask to speak with an officer.

# Public Works Update

### Water Main Extension Project Wrapping Up

The public water extension project on North 2nd St, West J Ave, and Maple Hill Estates is now in service, with the remaining components nearing completion. This partnership project with the KLA Group provides public water service to residents with private wells affected by the State's tightening of safe drinking water standards for groundwater contaminates associated with the historic KL Ave Landfill. The project installed 9,200 feet of water main to provide public water service to 64 properties.

While the project necessarily removed many trees from the road right-of-way, the project scope will provide professionally recommended replacement trees. Because the pipe installation continued through October and November, the replacement tree work will now be completed in the spring when the weather improves. Per Road Commission of Kalamazoo County policy, the replacement trees cannot be planted in the road right-of-way. Therefore the Township will be seeking permission from the property owners to access their properties to plant the trees near the road right-of-way. A meeting with residents will be scheduled to coordinate this phase of the project and the types of trees the property owners want planted.

### KL Ave Sewer Completed

Oshtemo Township completed a <sup>1</sup>/<sub>2</sub> mile sewer extension under KL Ave between 8<sup>th</sup> and 9<sup>th</sup> Streets, and a short extension south on 8<sup>th</sup> St to the railroad tracks. This project extends a major sewer interceptor and provides the primary sewage collector for the industrial-zoned area along KL Ave and 8th St. In accordance with newly adopted County Road Commission pavement preservation policies, residents should expect to see the new road chip sealed in 2018 or 2019 to enhance the longevity of pavement's water seal. Research studies have shown that a new pavement will last longer and require less maintenance (i.e., a tax payer savings) if a chip seal is applied 1-2 years following new roadway construction.



### USDA Rural Development Loan for Sewer Expansion

The United States Department of Agriculture (USDA) Rural Development agency has tentatively accepted the Township's loan application for sewer work in 2018-19. Due to budgetary constraints at the USDA, our overall public sewer project will be funded in stages. The first phase is \$8.35M to install sanitary sewers in Beech Ave, the plat neighborhoods of Fairlane, Meridian, Sky Ridge and Whitegate Farms, and a sewer extension along West Main between 7th and 8th Streets with a sewage pump station about ½ mile north on 7th Street. Subsequent stage(s) will be submitted as new loan applications to USDA each fiscal year thereafter, working in coordination with available USDA funds. Topographic survey and engineering design work has been initiated. The Township is in the final steps of working with USDA of the grant/loan process, and USDA underwriting. The USDA has stated Oshtemo is eligible for some grant money in addition to a steeply discounted-rate for loan financing.

### **Mandatory Sewer Connections**

The USDA loan will be paid through fees for new sewer service connections. For fairness and consistency, this mandatory connection requirement is extended throughout the Township in the manner applicable to state statutes. That is, properties that have sewer service available will need to connect within two years of receipt of formal notice from the Township. Beginning in 2018 the Township will begin sending mandatory connection notices to the 300+ properties that have sewer service available but have not connected. Homes with septic systems installed within the last 15 years may be allowed to extend the window to complete their sewer connection out until their septic system reaches 15 years of age. The Township currently assists home owners with financing the sewer connection fee by offering an installment-payment agreement to home owners. A payment plan of up 20 years is currently available, and may be extended further by the Board based upon the length of financing provided by USDA to the Township.

# Public Works Update Cont.

### WMU Business Technical Research Park 2.0

In 2018 Oshtemo Township will be partnering with Western Michigan University and the City of Kalamazoo to expand the WMU Business Technical Research Park, along the west side Drake Road, north of Parkview Avenue. The project is informally known as BTR 2.0. Oshtemo Township will be contributing the public water and public sewer system within the site in anticipation of future connection fees.

## Drake Road Non-Motorized Path

The Michigan Department of Transportation (MDOT) has informed Oshtemo we will receive grant money to help build (in two segments) a non-motorized path along Drake Road, from West Main Street to the railroad tracks. The Township is currently finalizing the lengthy process of acquisition of any remaining easements needed to proceed. The 2018 project is being constructed in two segments due to two separate grant programs being used by the Township. The remainder of the path from the railroad tracks to Stadium Drive is dependent on Amtrak's acceptance of the proposed railroad crossing improvements. If we receive timely Amtrak approval, we will proceed with a pending third MDOT grant to construct this remaining segment. Otherwise, the non-motorized path between the railroad tracks and Stadium Drive will be deferred until the following year.

# Master Plan Update

The Oshtemo Township Master Plan provides the long-range vision for our community, guiding the use of land to better realize that vision. In 2017, the Township Planning Commission began work on updating this plan per the requirements of the Michigan Planning Enabling Act. This five-year update focused on four main topics, which include:

- Planning Drivers those key trends influencing land use planning and development at the local level.
- Rural Character Preservation Strategy a set of goals and tactics to save rural character in the western portion of the Township.
- Maple Hill South Sub-Area Plan an area of the Township outlined in the 2011 Master Plan where land use changes are expected to occur within the next 10 years.
- Future Land Use Plan the desired land use vision for the Township.



The Planning Commission held their required public hearing on the draft Master Plan Update on December 14, 2017 and a recommendation of approval was forwarded to the Township Board. It is now time for the Township Board to begin their deliberations. The first meeting for this review will be a joint meeting with the Planning Commission, which is scheduled for Thursday, January 25th at 7:00 pm. The full draft Plan is currently available on the Planning Department's webpage at <u>www.oshtemo.org</u>.
