It's that time of year again! Nice weather is often used as an opportunity to connect with people in neighborhoods by going door-to-door. With few exceptions, anyone conducting door-to-door business is required to register with the Township Office. Our Hawkers, Peddlers & Solicitors Ordinance also requires that "No Trespassing"

signs be obeyed or be subject to an ordinance violation ticket. Ask the solicitor if they have registered with the Township, and they should have a license in their possession. Registration helps prevent scams. Exceptions for door-to-door activity include, but are not limited to, political and religious communication.


Election Inspectors Needed

Agritourism in Oshtemo Township



Recently, Oshtemo completed an update to the Township's Master Plan, which included a set of strategies for the preservation of rural character. The Rural Character Preservation Strategy chapter states the following:

"The natural and social value of rural areas is being increasingly recognized, including the key contributions that rural areas provide to food production and the local economy, as well as the environmentally significant lands that are preserved within rural areas. Given the importance and attraction of rural areas, communities are recognizing the critical need to identify and preserve cherished rural characteristics so that they can be enjoyed for future generations."

During the public outreach for the rural preservation strategies, many residents indicated a desire to have more economic opportunities associated with agriculture and agricultural related activities. This led to a set of policies and strategies for the development of agricultural enterprises, specifically addressing the lack of regulatory permission within the Township's Zoning Ordinance for agritourism uses.

Agritourism is typically defined as an agriculturally based operation or activity that brings the public to a working farm for the purpose of enjoyment, education, or active involvement in the farm operation. These activities can range from small roadside farm stands where seasonal fruits and vegetables are sold to large centers that operate year-round and provide a multitude of agriculture experiences.

The Township Planning Commission is currently reviewing possible changes to the *AG: Agricultural* and *RR: Rural Residential Districts* to permit agritourism if certain conditions can be met. These zoning districts are generally found west of 8th Street, where a more rural development pattern is found and is expected to continue.

The possible changes to the Zoning Ordinance would provide more economic options to property owners within this area of the Township. However, these opportunities also have to be tempered with the desired character of the area and the peace and enjoyment of other private property owners. Possible changes to the Ordinance will be discussed over the next few months. Watch for postings on the Township's website of the draft language and additional public input opportunities. Oshtemo Fire and Rescue—

Oshtemo Township Fire and Rescue (OFD) has been awarded a 100% grant from the Firehouse Subs Public Safety Foundation to purchase some replacement firefighting personal protective equipment (PPE). The grant totals \$28,151.

Firefighting PPE is routinely subjected to various hazardous chemicals which degrade its protective capacity over time. Knowing this, the National Fire Protection Association (NFPA) has produced a standard that requires the gear to be automatically taken out of service when it reaches 10 years. More often than not, the gear does not last a full 10 years due to unrepairable tears, extensive exposure to heat or becoming contaminated with a chemical that is not removable.



This grant application was a collaborative effort between OFD and our local Firehouse Subs restaurant (1750 South Drake Road, Kalamazoo) owners Ms. Susan Cornish and Mr. Bobby Kusmack. It was through their indulgence and guidance that our application was deemed worthy of funding by the Foundation.

Firehouse Subs Public Safety Foundation was founded in 2005 and has since granted over \$31 million in 46 states benefiting 3,175 organizations. It is their desire to provide equipment, training, and support to their hometown heroes.

Oshtemo has received the funding necessary to replace:

Nine (9) sets of structural firefighting turnout gear (coats and pants) totaling \$20,496.

Three (3) fire helmets totaling \$1,065.

Twenty-two (22) pairs of firefighting boots totaling \$6,590.

KALAMAZOO COUNTY SHERIFF'S DEPARTMENT

Kalamazoo County residents have been reporting numerous thefts from parked cars in recent weeks. There are several guidelines to follow which will reduce the chances of having your property stolen from inside your vehicle.

What can you do to prevent a larceny from your vehicle?

- 1. Lock your vehicle. Many reported vehicle break-ins occur when owners neglect to lock vehicle doors.
- 2. Hide valuables from sight or take them with you. If a person sees valuable property in a vehicle in plain sight, there is strong chance they will either break a window or try other means to gain access. If you do have property in your vehicle, place the property in the trunk or place it where it cannot be seen from the windows.
- 3. Park in areas that are not secluded. Park in well-lit areas which make it visible to the general public.
- 4. Never leave electronics in vehicles where they can be seen when the vehicle is un-attended. After market car stereos; consider models with removable faceplates. Take the faceplate with you when you leave your vehicle.
- 5. Always record serial numbers of purchased goods. If stolen, it makes the item easier to find when recovered by law enforcement.

Public Works Update

Sewer Connection Notices

The Public Works Department continues to send out sewer connection notices where service is available. About one-half of the 320+ properties with access to public sanitary sewer service have had a mailing sent to the owners that remain on private septic systems. Homes and businesses with groundwater leaching systems beyond a presumed 15-year service life will be required to connect to the public sewer within two years of receipt of the letter. The Township has a 20-year payment plan to help finance the sewer connection fees at an interest rate equal to Prime Rate + 1%. Another option is the USDA Guaranteed Loan program for homeowners which is 20 years at 1% interest rate; however, income limitations apply.

Sewer Extension Project


The Public Works Department has completed topographic surveys of the neighborhoods in Phase I of the sewer extension project (Beech Ave, Skyridge, Whitegate Farms, Fairlane, Meridian/Sunset, and West Main between 8th Street and Township Hall). Sewer design will proceed through the summer. While the USDA has not yet provided a formal funding letter, we have been told informally that the letter is coming. The delay is for a good reason: The Michigan office of the USDA received about three times more funding than anticipated so they are trying to figure out how to distribute the extra funds. We are using this opportunity to seek additional funding to do the Phase II & III neighborhoods sooner.

Sidewalks with Sewer

The Township Board recognized that building sidewalks with the sewer extension project is an opportunity to reduce the cost of the sidewalks. This opportunity warrants further consideration and community dialogue. Conceptual designs are being developed for core sidewalk connections within and adjacent to the Phase I sewer extensions. Meetings with residents in those neighborhoods are scheduled for early May to get their input on the sidewalks. The USDA loan cannot pay for the sidewalks. The Township Board has not decided how the addition of sidewalks will be funded. In late May or early June, the Public Works Department will present a sidewalk plan tailored for each neighborhood work area with estimated costs. This is to support the Township Board's further discussions on proceeding with the project and possible funding sources.

Intersection Redesigns, Almena Drive

This summer the Road Commission of Kalamazoo County will realign the intersections at Almena & KL Ave and Almena & 1st Street. The purpose of the realignment is to improve visibility and safety for drivers turning onto Almena. Additionally, the section of KL Ave between Almena and 1st Street will be abandoned and the road right-of-way returned to the adjacent property owners. A graphic showing the realignment is below.
