The Oshtemo Township Public Meeting was held virtually using the Zoom platform. Residents were able to join the meeting through both the Zoom application and by phone. Residents were able to give public comment through email, the Zoom platform, and by phone during the meeting. Supervisor Heiny-Cogswell called the meeting to order at approximately 6:00 PM.

WORK SESSION ITEMS

Update and discussion regarding single waste hauler

Assistant Supervisor Josh Owens presented information regarding single waste hauler service in the Township. The competitive bid process could result in lower costs for homeowners, fewer trucks on the roads, and decreased air pollution from the large trucks. ~~Board consensus was to send out a request for proposal so that actual numbers can be presented.~~ No decision was made to change to single hauler. Board asked for additional information to bring back for discussion at a future meeting.

Consideration of Fire Alarm Ordinance Amendments – First Reading

Attorney Porter presented the fire alarm ordinance amendments with the objective to revise Sections 3 and 4 of the Township False Alarm Ordinance 415, update the Ordinance to reflect current circumstances and procedures, simplify the fine structure and violation period to improve record keeping and fair enforcement, and ensure the Ordinance is clear to the Township's property owners.

Supervisor Heiny-Cogswell opened public comment. No public comment.

Motion by Farmer, second by Ford to approve the fire alarm ordinance amendments for first reading and set second reading for February 9, 2021. Roll call. Motion carried 7-0.

Consideration of Zoning Ordinance Amendments – First Reading

a. Pools on corner Lots (Front Yard Setback)

Planning Director Iris Lubbert presented the history and context for the amendment request.

Supervisor Heiny-Cogswell opened public comment. No public comment.

Motion by Bell, second by Ford to approve the pools on corner lots amendment for first reading and set second reading for February 9, 2021. Roll call. Motion carried 7-0.

b. Child and Adult Care Centers

Planning Director Iris Lubbert presented the history and context for the amendment request.

Supervisor Heiny-Cogswell opened public comment. One person spoke.

Motion by Farmer, second by Buszka to approve the child and adult care centers amendment for first reading and set second reading for February 9, 2021. Roll call. Motion carried 7-0.

Consideration of Sewer Installment Agreement Rate Setting Schedule Resolution

Treasurer Clare Buszka presented the resolution to amend the Amended and Restated Sewer Main Connection Charges and Water Connection Charges.

Supervisor Heiny-Cogswell opened public comment. One person spoke.

Motion by Heiny-Cogswell, second by Bell to adopt a resolution to amend the Amended and Restated Sewer Main Connection Charges. Roll call. Resolution adopted 5-2, with Ford and Farmer voting No.

Motion by Heiny-Cogswell, second by Bell to adopt a resolution to amend the Amended and Restated Water Connection Charges. Roll call. Resolution adopted 5-2, with Ford and Farmer voting No.

Other Business

Item e from the Consent Agenda- Federal Poverty Exemption Guidelines-
Supervisor Heiny-Cogswell opened public comment. One person spoke.

Board consensus was to bring the item back on February 9, 2021 for further clarification of the guidelines for auditing.

Board Retreat- Trustee Ford requested a board retreat and continued equity training. ~~with Reverend Karika Parker to continue equity training and Township planning.~~

Green Burials- Clerk Farmer shared that the Township has sold the burial rights for two green burial spaces, with four more likely in the next week.
