

#### Infrastructure News

#### **Non-Motorized Facilities**

Oshtemo continues to proactively seek opportunities to fund and construct the non-motorized facilities outlined in the Master Plan/GO! Green Plan, Regional Metropolitan Transportation Plan (overseen by the Kalamazoo Area Transportation Study [KATS]), and as desired by residents in the community survey.

#### **KL Ave Shared-Use Path**

#### Phase 1 - Drake Road east side of US-131

Complete! We received \$240k in grant funds from Transportation Alternatives Program (TAP).

#### Phase 2 – east side of the US-131 bridge to the Paddock Apartments (north side)

We've received over \$1M in TAP grant funds from the Michigan Department of Transportation (MDOT). The projects are scheduled based on the coordination with the MDOT US-131 bridge over KL Avenue replacement project.

#### Parkview Ave Shared-Use Path: 11th Street to Drake Road (north side)

The design has been coordinated with new roundabout projects. The township is working on the design over the bridge and plan to complete installation from Drake Road to Vienna Street in 2024.

## 9th Street Sidewalk: Stadium Drive to Quail Run Drive (west side)

Oshtemo was awarded a (TAP) grant for \$543k! We are currently finalizing the design and easements. Construction is expected to take place in late 2024 or summer 2025.

This sidewalk will connect multi-family areas (mobile home park, multiple apartment complexes, and condos) and single-family residences to multiple schools, credit unions, medical offices, and the Oshtemo DDA commercial area. This project will serve all types of non-motorized transportation and users as well as allow for intermodal access by including bus stops. It also achieves the complete streets policies of MDOT, KATS, the Kalamazoo County Road Commission, and Oshtemo Township.



# Drake Road Shared-Use Path: Stadium Drive to KL Avenue (west side) with Amtrak crossing

In collaboration with our partners which includes the City of Kalamazoo, MDOT, and Amtrak, railroad crossings will be installed in June 2024. Oshtemo will complete the rest of the project by the end of 2025. This project will use TAP grant funds and complete a large segment on Drake Road.

The planning commission completed an inventory and assessment of ALL existing non-motorized facilities in Oshtemo. This information will help plan for routine maintenance and identify gaps in the network.

#### At Your Service

#### From The Clerk's Office

In 2023, the Clerk's Office moved forward with the implementation of a record digitization project that will eventually encompass all Township documents. This allows for easier access to current and historical documents for both staff and the public.

We also began working with the new Geographic Information Systems (GIS) Specialist to incorporate mapping and access to our cemetery system. This gives access to residents who are interested in learning more about the availability of plots without having to come into the office.

In addition, the Purchasing Policy for the Township was updated to focus on electronic payments for vendors, shifting away from paper checks, to increase security for Township funds.

2023 was busier than expected, including three unscheduled elections. The coming year will be even busier with four elections and the implementation of Proposal 2. We look forward to the opportunities next year will bring.

We would like to thank our election inspectors. Their dedication to public service and democracy is the bedrock of our work. We have over 20 Absentee Counting Board Inspectors, 10 Precinct Chairs, and 100 precinct workers; many of whom have worked on elections in Oshtemo for more than 10 years.

We thank these individuals for their efforts this year and look forward to working with them again in 2024!





# Safety News - 2023 Fire Department Highlights

Oshtemo Fire Department is excited to share highlights from 2023 which include adding to our talented group of firefighters, reintroducing community events, and joining a specially trained regional team.

So far this year, we have responded to 3,117 calls, averaging over 9 calls per day, and are on track to surpass last year's call volume by a significant margin. Being able to add two full-time firefighters and four paid, on-call firefighters has helped the department manage the call load as well as add to our knowledge and skillset.

Along with the new skills these firefighters bring, our existing crews have acquired more training. These courses range from very technical subjects, such as trench and structural collapse rescues, to investigation training and building leadership skills. These courses and conferences put the department in the best position to keep our township residents and visitors safe.

## New Comprehensive Master Plan

Oshtemo Charter Township is gearing up to create a new Master Plan. This is a valuable tool used to set priorities and direction for growth and development in the township.

The Michigan Planning Enabling Act requires that the Master Plan be updated at least every five years. The current plan was first adopted in 2011 with the most recent update in 2019.

Much has changed since then; Oshtemo is now the 85th most populated community in Michigan and the third-largest community in Kalamazoo County.

A comprehensive Master Plan is needed to reflect the growth the Township has experienced and guide future expansion while working to preserve a healthy community.

For this project, the Township Board has entered a contract with Progressive AE progressiveae.com, an accomplished national architectural, planning, and engineering firm based in Grand Rapids. The Master Plan will direct the Township's future with a strong emphasis on land use, placemaking, transportation, and economic development. The updated plan will honor and build upon the community's earlier planning efforts.

Initial work on the plan has begun and is expected to be completed in 2025.
